Dear Leadership Council Representatives,

New Year Greetings to you! We hope that this message finds you and your communities well.

During our most recent Leadership Council (LC) meeting in December, we realized that there is a communication gap that exists between ISMETA and some of the Approved Training Programs and Affiliation Professional Organizations. It seems that some of the LC representatives were not aware of a number of resources that ISMETA offers to our individual and organizational members. To address this gap, we offer a new resource: the Leadership Council newsletter! The idea is to offer a concise summary of key information that the LC organizations need to know. Welcome to the inaugural issue!

- The first and most time-sensitive announcement is that we will hold free, virtual Open Houses for current students and graduates of training programs on January 10th at two times to accommodate schedules in different parts of the world: 12 pm Eastern and 8 pm Eastern U.S. time. *Please share the attached postcard with your mailing lists*. Two Open Houses will also be offered on April 10, 2024 at 12 pm and 8 pm. Registration links for those events are provided on the attached postcard.
- To address the communication gap between Leadership Council organizations and ISMETA, we will now require all organizational members to attend all four of the annual Leadership Council meetings, with the option of viewing recordings for up to two meetings per year. That is, to ensure that crucial information is shared and received effectively, all organizations must attend at least two Leadership Council meetings live and watch the recordings of the other sessions if it is not possible to attend them synchronously. - The Professional Development Center (PDC) is ready for member workshops and courses! The <u>Call</u> <u>for Proposals</u> went out on December 12 and can be found at the bottom of the landing page for the PDC.
 - All individual members (including you!) can submit proposals to teach workshops and courses. Please encourage people you know who might be interested to send us proposals.
 - If you know someone who is not a member but wants to teach, they can become a Friend of ISMETA for \$95. (A sliding scale fee is available for anyone who is experiencing financial challenges.)
 - Later this month, an invitation will go out to all Approved Training Programs to record an introductory video about the "Essential Elements" of their work to both publicize their training programs and to help define the profession of somatic movement education in the broader context of popular but vaguely defined "embodiment" and "somatic" practices.
- Our joint conference with the National Dance Education Organization (NDEO) is happening July 19 -21, 2024 in New York City. The deadline to submit proposals is February 29, 2024. You can read the details <u>HERE</u>. The Somatic Arts and Education Committee is organizing the review of proposals. The Equity, Justice, and Accessibility Committee has selected the theme of "accessibility" for the bi-monthly Community Conversations in 2024. All are invited to attend! The upcoming dates for these gatherings are: January 12, March 8, May 10, July 12, September 13, November 8 at 10:30 am Eastern U.S. time (with the possibility of shifting the time to accommodate any interest in Australasia if that arises).
