SUMMARY OF MEETING

Managing Director, Nirvan Ananda, welcomed everyone to the online gathering. Then, Aceneth García Vargas, who is the Director of the recently approved 500-hour training program, Elemental Movement in Mexico, facilitated a lovely Somatic Arrival.

Next, Executive Director, Elisabeth Osgood-Campbell, shared a PowerPoint presentation of the Leadership Council responses to the questionnaire that was sent out previously. Her slides are integrated into the video recording and are attached for your convenience. Richard Sims, Board President, presented these questions for groups of 2-3 people to discuss in breakout rooms for about 12 minutes:

- What potential benefits could come from increasing the percentage of live, online training hours?
- What potential benefits could come from increasing the percentage of pre-recorded training hours? What sort of follow up is required to insure learning through this format?

Then, another 10-minute round of breakout room discussions occurred in response to these questions, which were presented by Board Secretary, Maya Gayatri Andersson:



- How would a recommended minimum percentages for in-person learning affect your program or organization?
- How would a recommended maximum percentages for live, online learning and for prerecorded learning affect your program or organization?

Afterward, the groups reconvened in the main gallery to harvest important points from their small group discussions for 15 minutes.
